County Cllr Val Tarbitt gave a very good case for the application to succeed. As a council we will keep you all informed of the progress that is made.

Silhouette Soldier – Cllr J Twentyman

This is an initiative for the close of the 100 years sine the end of the 1st World War. We have the chance to purchase a 'silhouette soldier' which can be placed as a permanent fixture in a place of choice, at a cost of £750. It was discussed to share the cost with Kingmoor Parish Council because it was an event which affected both areas. It was suggested that a small event on Friday 5th October 2018 in the Rockcliffe Centre would be appropriate for anyone who wishes to attend, details will follow.
